April 11, 2023

 Gualala Community Center Ballot Measure – granting permission to the Board of Directors to approve spending over \$5k during the rebuilding project.

May 9, 2023

- Rebuilding Committee discussed the possibility of renting or purchasing a modular unit to house the PNT clothing department. Recommendation to the board was the cost and permitting process would be cost and time prohibitive.
- Rebuilding Committee Interviewed 11 potential architects to design the community center. The committee recommended three candidates for a second interview with the Board of Directors.
- Adrain Adams added to the Rebuilding Committee. Background structural engineering
- Robert Ramers replaced Rebecca Stewart as the Coastal Seniors representative.
- Rental Agreement executed by Bill Matthews for space to house the clothing department.

August 8, 2023
